信丰华锐钨钼新材料有限公司要求我们的供应商按照合理合法的贸易标准与我公司进行贸易往来，不从非洲冲突地区采购原料，只从对环境和社会负责任的供应商采购原料。为了达到这个目的，信丰华锐钨钼新材料有限公司做出以下承诺：

1、承诺我公司的供应链会保持尽职，要求我们的供应商提供必要的来源信息，以支持独立的非冲突矿物冶炼厂项目的第三方审计。

2、承诺一旦确认有供应商采购的原料直接或间接资助或有益于刚果或周边国家的武装组织，我公司将依据经合组织尽职指引及声明的要求，中止与该供应商的贸易。

South-east Nonferrous Metal Company Limited of Hengyang City Conflict Free Policy is to ensure that raw materials containing tungsten we purchased do not originate from any conflict areas.

Xinfeng Huarui Tungsten & molybdenum New Material Co., Ltd. requests our suppliers to conduct business with us according to ethical and legal business standards, not to source material from African conflict area and to only source materials from environmentally and socially responsible suppliers. In order to achieve this goal, Xinfeng Huarui Tungsten & molybdenum New Material Co., Ltd. makes following commitment.

-1. Commitment to supply-chain due diligence and require our suppliers to provide necessary sourcing information to support independent CFS 3rd party audit.

-2. Commitment to follow OECD Due Diligence Guidance including statement to discontinue business with any supplier confirmed to be purchasing materials which directly or indirectly finance or benefit armed groups in the Democratic Republic of Congo or adjoining countries
