

Membership Information

The Tungsten Industry - Conflict Minerals Council (the "Council" or "TI-CMC") operates under the auspices of the Refractory Metals Association, a trade association within the Metal Powder Industries Federation, a 501(c)(6) non-profit corporation. TI-CMC provides a mechanism through which tungsten producers can certify their compliance with U.S. Securities and Exchange Commission regulations pertaining to the conflict minerals provisions of section 1502 of the Dodd-Frank Wall Street Reform and Consumer Protection Act.

Membership in TI-CMC is open to firms, corporations or divisions that are smelters or refiners of tungsten. Membership is either category A (with validation through the Conflict-Free Smelter Program) or category B (without such validation).

The Council recognizes, however, that there are other firms or individuals that have an interest in the use of tungsten products and powders and wish to show their support for the TI-CMC initiative. With this in mind, the Council has created a Supporter category through which such firms or individuals may formally demonstrate their endorsement of TI-CMC and its objectives.

Supporter Category

Any firm, corporation, entity, or individual with an interest in the use of tungsten products or powders is eligible to become a Supporter. To join, the applicant must submit (1) an application form (attached), which must be approved by the TI-CMC Board, (2) a signed commitment letter in the form attached, and (3) (if applicable) a copy of the applicant's Commitment to Conflict Free Sourcing (Conflict Free Policy)..

Dues and Representation

Annual Supporter dues are \$500.

Each Supporter must designate an individual to serve as its Official Representative.

In matters affecting TI-CMC, a Supporter is not entitled to a vote.
